Obstacles: Kicker right, Kicker left, Funbox right, Curved Rail left 15m Pipe right, 20m Flatbox left, Stepdownbox right, 25m Straight Slider left, Rooftop right, Beast right Uprail left

All registrations after this date are "late registrations" and are possible until the 28th of June 2024, 4:00pm.

Categories:

- Mini Kids Boys / Girls Wakeboard (up to 11 years)
- Boys / Girls: (under 14)
- Junior Men / Ladies: (under 18)
- Open Ladies / Open Men: open for everybody without restrictions
- Masters: (over 30)
- Veterans: (over 40)

Combining categories: In case there are less than 3 competitors in one category, it will be mixed with the next higher category according to the Chief Judge.

Entry fee:

- Boys, Girls, Junior Men, Junior Ladies: 40,-- Euro
- Late Registration: 70,-- Euro

Liability

The organizer does not take over adhesion for persons-, special or financial damages opposite fighters, arbitrators, official ones, aids or thirdpersons. All fighters participate in each relationship on own danger, even if they engage themselves outsideof the match, e.g. in the masterprogram. With the participation the runners do without any demands of requirements from all cases of damage, which result directly or indirectlyfrom the meeting. All participants must be liability-insured accident-and/or. The requirements of the condition and the safety precautions of thematch distances depend on the valid in each case regulations of the international water ski and wakeboard federation (IWWF) region Europe &Africa (E&A), the national water ski and wakeboard federation (OEWWV), the valid in each case regulation and delivering mode of the OEWWVand the valid in each case agreement (product requirement specifications) between the organizing committee (OK ONE) and the OEWWV,whereby the arrangements of the respective arbitrator are determining. Each participant commits itself to speak own objections the arbitrator. Withhis start the fighter gives to recognize that the given condition of the match distance and existing safety precautions are suitable as and aresufficiently recognized. An adhesion for a certain condition of the match distance or certain safety precautions, going beyond that, does not takeover the organizer. All athletes get the adhesion explanation during the registration suburb to the signature submitted.
